(Tech II), respectively. 1,253,796 shares of Common Stock are held by QP, 339,050 shares of Common Stock are held by Cayman, 724,450 shares of Common Stock held by PE, 32,794 shares of Common Stock are held by Tech and 161,179 shares of Common Stock held by Tech II. The interest of Marxe and Greenhouse in the shares of Common Stock owned by QP, Cayman, PE, Tech, and Tech II is limited to the extent of his pecuniary interest.
