(Cayman), Special Situations Private Equity Fund, LP (PE), Special Situations Technology Fund, L.P. (Tech) and Special Situations Technology II, L.P. (Tech II), respectively. 458,200 shares of Common Stock and 264,050 Wts are held by Cayman, 811,800 shares of Common Stock and 434,750 Wts are held by PE, 36,637 shares of Common Stock and 22,878 Wts are held by Tech and 184,563 shares of Common Stock and 116,922 Wts are held by Tech II. The interest of Marxe and Greenhouse in the shares of Common Stock owned by Cayman, PE, Tech, and Tech II is limited to the extent of his pecuniary interest.
