- Purchase option shares become exercisable in four installments; 10,000 shares on July 2, 2014, 10,000 shares on July 2, 2015, 10,000 shares on July 2, 2016 and 10,000 shares on July 2, 2017.
- The amount represents the total number of derivative securities Beneficially Owned of the class shown (i.e. the same exercise price and expiration date). The Reporting Person owns a total of 80,000 Options to Purchase Common Stock of varying classes (i.e. varying exercise prices and expiration dates).
